3. Items for Discussion

3.1 Various Protests – Saturday 6th February

Members were informed of the protests that had come in just in case an appeal against a Fixtures and Events decision was made and BMC members were required to hear the appeal.

3.2 Umpire Course – Training in Pennant COP

In one of the protests, a newly approved umpire was the Umpire of the Day and he expressed in his explanation that although he was aware there was one, he was unaware of where to find the pennant wet weather rules until after the fact and was looking in the Laws of the Sport book.

(PB) said there was time spent in the course on the local rules and conditions of play in the BWA Officials Handbook and he would follow up on why there may have been a break down.

Further conversation detailed how many managers and players especially had very little understanding of the rules and were unlikely to educate themselves by reading them. It was put forward that BWA make a number of short videos going through some of the more important rules e.g., weather and cross gender, and sending them out at the start of the season for people to educate themselves
