- **As Per 11.2 (i)** (page 38 BWA Handbook), The team in the higher Division will host AM and PM finals
- **As Per 11.2 (ii)** The same green must be used for AM and PM Finals.
- Clubs mentioned first in each fixture are required to use Pennant Stickers.
- Clubs taking part in the AM game are to report to the venue by 9.00am for 9.15am trial ends.
- The PM game start is scheduled for 1.30pm but adjustments can be made between the two competing clubs on the day.
- Competing Clubs NEED TO provide an umpire each either nonplaying or playing for the AM round.
- Host Clubs should contact the Visiting Clubs to let them know if lunch options are available. If No contact is made, clubs should assume lunch will not be available.
- Bowls Link will be open for clubs to input teams after Midday on Thursday 21<sup>st</sup> March.
