- Premier League and 1st Division Grand Finals to be played Saturday 23rd and Sunday 24th March 2024.
- 2nd Division to 4th Division and 6th Division to play Saturday 23rd March 2024 Only.

- Clubs taking part in the AM game are to report to the venue by 9.00am for 9.15am trial ends.
- Clubs mentioned first in each fixture are required to use Pennant Stickers.
- Host Clubs should contact the Visiting Clubs to let them know if lunch options are available. If No contact is made, clubs should assume lunch will not be available.
- For the PM round, both competing clubs have 2 trial ends on the rink they are playing on.
- The PM game is scheduled to start at 1.30pm but adjustments may be made between the two competing clubs on the day.
