

## **ANSWERS - QUESTION PAPER 6**

- 1. No. Law 5.1.1 However, the Controlling Body is able to make a decision on trial ends
- 2. No. Law 29.3.1
- 3. 2 metres and 25 metres from each end ditch. (Domestic Regulation 23 metres) Law 49.12
- 4. The Umpire must remove the dead bowl. The opponent must then choose whether to replace the head, leave the head as altered, or declare the end dead. Law 8.3
- 5. The Umpire must leave the jack in its position. No-one has the right to challenge the legality of the original position of the jack after the first player to play has delivered the first bowl. Law 9.7
- 6. The Skip must call the Umpire who will measure in a straight line, the distance between the nearest point of the bowl and the centre of the mat line if it is less than 14 metres then the bowl must be declared dead. Law 17.1.3
- 7. The third can
  - a. measure any, and all disputed shots.
  - b. tell the skip the number of shots scored for or against their team as each end is completed. Law 40.2
- 8. An opponent must put the jack back to its former position and remove the non- toucher from the rink. Law 38.5.2
- The skips must ask the Umpire to decide on the disputed point. If the Controlling Body has not appointed an Umpire, the skips must choose a competent neutral person to act as the Umpire. Law 40.1.5 and 40.1.6
- 10. No. The bowl must be left in its new position and the process of deciding the number of shots scored must continue. All shots agreed before the bowl fell will count. Law 23.6.3
- 11. The jack and any bowls which have come to rest within the boundaries of the rink of play and are not dead. Law C13
- 12. The skip in 'Team 'B' has acted correctly. The bowl must be returned to be played in the proper order. Law 29.1.1
- 13.
- a. Dead end: An end can be dead for many reasons (for example, when the jack is declared dead in line with law 19.1 and 30.1). A dead end is not a completed end and must be replayed. Law 19.1
- b. Tied end: An end is tied if the nearest bowl of each team is touching the jack, the same distance from the jack, or if no live bowls are left within the boundaries of the rink of play. A tied end is recorded as a completed end. Law 24

- 14. Yes- as long as the Controlling Body gives approval, there is enough time available without delaying the competition and another rink is available apart from that on which the player has been drawn to play later that day. Law 4.1 The Controlling Body makes the decision.
- 15. Wait for a maximum of 30 minutes or shorter time, if stated in the Conditions of Play, to see if the missing player arrives. If the player does not arrive, then the game is forfeited. Law 39.1.2
- 16. Yes. Subject to agreement by the opponents. Any absence from the green, however, must be for not more than 10 minutes. Law 32.1
- 17. The toucher must be put back to its former position by an opponent and the non- toucher must be removed from the rink of play. Law 37.7

18.

- a. Yes The player is in possession of the rink. Law 42.2.5
- b. Yes Law 42.2.5
- 19. The jack must be put back to its former position. If the skips cannot agree on its position, the end must be declared dead. Law 35

## 20.

- a. A 'Team' is either a Four, a Triple or a Pair. Law B3
- b. A 'side' is any agreed number of teams or Singles players (or a combination of teams and Singles players) whose combined scores decide the result of a competition. Law B1
- 21. Another extra end must be played. The skips must toss again and the winner must decide who will play first.

Laws 28.4, 28.5

- 22. The skip of the team which played the bowl must choose whether to:
  - a. have the bowl replayed.
  - b. place the bowl where the skip believes it would have come to rest. or
  - c. leave the bowl where it came to rest. Law 37.1.1.3
- 23. Stop the bowl and return it to be replayed. Laws 37.6.2, 37.6.3
- 24. The players must place the jack where they believe it would have come to rest. If they cannot agree, the end must be declared dead. Law 38.3.2
- 25. The skip of Team 'A' can appeal to the Controlling Body. However, the appeal must be made to a representative of the Controlling Body no later than 24 hours after the final end of the game affected is completed. Laws 36.1, 36.2, 36.3
