

POLICIES

Bowls Australia governs the sport of bowls in Australia and shapes policies on various significant matters not covered in the laws.

Officials must be familiar with Bowls Australia policies, which are frequently updated and can be found on the Bowls Australia website and in the law book following the Domestic Regulations.

States and Territories may modify Bowls Australia policies to meet their specific requirements provided these modifications are specifically stated in the policies. Otherwise, Bowls Australia policies must be followed Umpires and officials must refer to specific 'Bowls Australia' and 'State' policies when handling situations such as player eligibility, offensive language, smoking on the green, and extreme weather conditions.

Officials are required to complete various documents related to specific situations, such as the 'Instantaneous
