# DEFINITIONS

## A. CONTROL

- 8. Controlling Body
  - a. What defines a 'Controlling Body'? The body with immediate control over the 'Conditions of Play' under which a game is played.
  - b. Who might the 'Controlling Body' be for the following events?
    - i. Club Pairs Championship Club Match Committee
    - ii. 'Australian Open' Bowls Australia
    - iii. State Fours Championship State Match Committee

## B. PLAYERS

- 9. 'Side' and 'Team'
  - a. What is the difference between a 'side' and a 'team'?
    A side is Any agreed number of teams or singles players (or a combination of Teams and Singles players) whose combined scores decide the result of a game.
    A team is a Pair, a Triple, or a Four
  - b. Name a 'side' competition you are familiar with. e.g. Pennant
  - c. Name a 'team' competition you are familiar with. e.g. State Fours Championship, Club Pairs etc

# C. PLAY

- 10. Defaulting player, team or side
  - a. What is a defaulting player, team or side'? The player, team or side that does not meet the requirements of any specific law or laws.
  - b. Find a definition which describes the consequence of a defaulting player, team or side?
     C10 Forfeited Game a game that is awarded to an opponent as a penalty for the defaulting player, team or side not meeting the requirements of one or more laws.
- 11. 'Displaced jack and bowl'
  - a. How does Definition C4 'Displaced jack or bowl' relate to Definition C11 'Former Position'? A 'displaced jack or bowl' (in most cases,) must always be placed back to its 'former position'.
  - b. What section of the Law Book deals predominantly with 'a displaced jack or bowl' and 'replacing the jack or bowl to its former position'?
     Section 2.3 Bowl and Jack Displacement
- 12. What constitutes an 'end' in a game of bowls?

C7 Delivery of the jack, delivery of all the bowls required to be played by all of the opponents in the same direction on a rink, and deciding the number of shots scored.

- 13. What is the difference between a 'bowl in its original course' and a 'bowl in motion'?
  - a. A bowl in its original course C15 A bowl from its delivery, until it comes to rest, no matter how many times (for a bowl) it comes into contact with the jack or other bowls before it comes to rest or becomes dead.
  - **b.** A bowl in motion a bowl which is moving during play after being at rest as part of the head.

14. Provide three examples of a:

- a. Neutral person -
  - I. Umpire
  - II. Marker
  - III. spectator
- b. Neutral object -
  - I. Line jack or bowl belonging to a player on a neighbouring rink
  - II. Any object not belonging to a player on the rink.
  - III. A dead bowl that is at rest and has not been removed from the rink of play
- c. Is a pencil belonging to a player on the 'rink of play' a neutral object?
   No
- 15. What is a 'jack high' bowl'?

The nearest part of a bowl is in line with and the same distance from the mat line as the nearest part of the jack.

- 16. What is the difference between the terms: 'rink' and 'rink of play'?
  - a. Rink The section of the green on which a game is played.
  - b. Rink of Play The section of the green and the corresponding sections of end ditches on which a game is played.
- 17. What is defined as the 'side boundaries' of the rink of play? Imaginary straight lines connecting the centres of the boundary pegs on opposite banks that show the limits of the rink of play.
- 18. What are the heads of shot indicators (paddles) required to match? The heads of the indicators match either the colours of the adhesive markings on each player's bowls or the colours of each player's bowls.
- 19. Who is the visiting skip when skips of competing teams are playing at a neutral venue? The skips of the second named team in each pair of competing teams when games are being played at a neutral venue.

### D. BOWLS

- 20. What constitutes a 'set of bowls'?
  - Four bowls, all of which are a:
    - I. of a matched set.
    - II. of the same make and model and
    - III. of the same size, weight, colour, bias, serial number and engraving.

#### 21. What is a 'Working Reference Bowl' and why are they required?

A bowl approved by world bowls as

- I. having the minimum bias required and
- II. in all other respects following the laws of the sport of bowls.

Each working reference bowl is engraved with the words working reference bowl and World Bowls makes sure that each Licenced Tester is given a working reference bowls.
